Reminder that your rental is not reserved until your deposit has been received.

This agreement is between the Town of Gravelbourg

And

___ "lessee"

for the use of the Palestre: skating rink, curling rink, curling lounge, or facility equipment.

- All areas are non-smoking.
- A security damage deposit is required at time of booking.
- The Palestre rental fee is to be paid no less than 30 days prior to the rental date.
- The security damage deposit will be returned to lessee by regular mail within 14 calendar days of the event. If any evidence of smoking or damage inside the Palestre is found, the security damage deposit will be withheld in full and payment for any damages will be the lessee's responsibility.
- Damaged tables: \$100/each. Damaged chairs: \$25/each. Repairs or replacement costs for damaged property will be billed to the lessee.
- If the event is cancelled more than 30 days prior to rental date, all monies shall be refunded in full. Rental fees are non-refundable if the event is cancelled within 30 days of the rental date.
- No person under the age of 25 may rent the Palestre.
- A weekend rental rate is from 9am Friday morning until 5pm Sunday afternoon. If additional days are needed for preparations, there will be a surplus charge of \$100.00 per day, taking into consideration that not all the lights are turned on.
- Lessee is responsible to leave the Palestre in a tidy condition:
 - Only sticky tack is allowed to hang decorations. NO TAPE.
 - Confetti, rice, rose petals and bubbles are not permitted.
 - Remove garbage from all containers and deposit in the dumpster. Cardboard taken it IPI.
 - Clean bathrooms (toilets, sinks, countertops and floors).
 - Clean the kitchen (dishes, cutlery, counters, fridge, floors, stove, grill and microwave)
 - Wipe off tables. Collapse and stack tables & chairs and place on trolleys.
 - Sweep and wash floors.
 - Remove all personal belongings.
 - Pick up and dispose of any garbage (including pet waste) from parking lot and grounds.
 - Check and secure doors, turn off lights and return key as directed.
- A permit is required for any alcohol brought into La Palestre. Maximum capacity for the skating rink is 700, the curling rink is 400 and the curling lounge is 125.
