BYLAW NO. 1364/12

A Bylaw of the Town of Gravelbourg to provide for the visible display of property addresses for houses and businesses along the streets or roads of the Town of Gravelbourg

WHEREAS the Municipalities Act, PT II 8(1)(b) authorizes a Council to pass by-laws for purposes respecting the safety, health, protection and well-being of people, and the safety and protection of property;
AND WHEREAS the Council of the Town of Gravelbourg deems it necessary and expedient to require visible display of property addresses for the safety and protection of people and property;

Now Therefore:

**The Council of the
Town of Gravelbourg,
in the Province of Saskatchewan,
enacts as follows:**

1. That the owner of each lot on which there is a building, house, or structure along a street or road in the Town of Gravelbourg shall affix and maintain in legible condition a number or numbers as designated by the Town of Gravelbourg to the front of each building, house or structure fronting on a street.
2. Such numbers shall be:
 - a) affixed in conspicuous places visible from the street or road during the day and night;
 - b) no less than 7.62 cm (3 inches) in height;
 - c) of contrasting colour to the building, house or structure to which it is affixed; and
 - d) durable to withstand all weather conditions.
3. Any owner of a lot on which there is a building, house, or structure requiring a number as aforesaid shall provide the same at his/her own expense and in the event of the failure to do so, the Town may erect such number or numbers at the expense of the owner.
4. The Town shall make and keep a record of the streets and numbers of the buildings, houses, or structure and it shall be the duty of the Town to assign a number as aforesaid to each building, house, or structure.
5. No person shall injure, deface, pull down or destroy any such number.
6.
 - a) Any person who commits an infraction of the provisions of this bylaw is guilty of a summary offence and liable upon summary conviction to a fine of \$50.00.
 - b) Where a voluntary penalty amount of \$30.00 is paid to the Town of Gravelbourg within 5 days of an infraction of these provisions occurring, the Town will relieve the offender of any further actions toward that infraction
 - c) A Bylaw Enforcement Officer or Peace Officer may issue a warning for which no prosecution will be carried out and no fine shall be levied, if the person has not previously been charged with an offence pursuant to this bylaw.

7. a) Any person who contravenes or disobeys, or refuses or neglects to obey any provision of this bylaw is guilty of an offence and is liable, on summary conviction, to a fine of not less than \$100.00 or more than \$200.00 for each day's neglect or failure to comply therewith and in default of payment of the fine, to imprisonment for a term not exceeding thirty (30) days.
b) Any person who hinders or obstructs the Bylaw Enforcement Officer, Peace Officer or any other representative of the Town under this by-law in the exercise of their duty is guilty of an offence and liable on summary conviction to a fine of not less than \$100.00 or more than \$200.00, and in default of payment of the fine, to imprisonment for a term not exceeding fourteen (14) days.
8. If any provision of this bylaw is held invalid by a court of competent jurisdiction, the remainder of the bylaw shall not be affected thereby. The invalidity of any section or sections or parts of any section or sections of this bylaw shall not affect the validity of the remainder of the Town of Gravelbourg's Property Address Bylaw.
9. This by-law shall come into force and take effect August 01, 2012 .
